



## REDNER'S MARKETS, INC. SWEEPSTAKES OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** Sweepstakes (the "Sweepstakes") is open only to those who enter and who are 18 years old as of the date of entry. The Sweepstakes is only open to legal residents of Pennsylvania, Delaware, Maryland, New Jersey and is void where prohibited by law. Employees of Redner's Markets, Inc.
