

MARCH MANIA SWEEPSTAKES OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN.
A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. SPONSOR: MARCH MANIA SWEEPSTAKES (the "Sweepstakes") is sponsored by Redner's Markets, Inc. and Utz Quality Foods, LLC (the "Sponsors"). Questions or comments are to be directed to the Sponsors via email at info@rednersmarkets.com or mailing MARCH MANIA SWEEPSTAKES, C/O Render's Markets, 3 Quarry Road, Reading, PA 19605. Entry information is owned by the Sponsors. The entry information provided will only be used in the event that entrant is selected as a Sweepstakes winner or if the entrant has indicated they would like to receive additional information from the Sponsors.
- 2. ELIGIBILITY: NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The Sweepstakes is open only to those who enter and who are 18 years old or older as of the date of entry. The Sweepstakes is only open to legal residents of Pennsylvania, Delaware, Maryland, New Jersey and is void where prohibited by law. Employees of the Sponsors, their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate and extended family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

(2) <u>Mail-in Entry</u>: Send a postcard to MARCH MANIA SWEEPSTAKES, C/O Render's Markets, 3 Quarry Road, Reading, PA 19605 and include your name, address and phone number and agreement with the Official Rules to be entered. Postcards must be postmarked no later than April 6, 2022 and be received by April 13, 2022.

All entries become the property of Sponsors and will not be acknowledged or returned. False or deceptive entries or acts, as determined by Sponsors in their sole discretion, will render the entrant ineligible. Participants represent and warrant that they have not purchased any kind of device or Internet service in order to submit an entry or participate in and/or enter the Sweepstakes.

Maximum of one (1) entry per person. Entrants may not submit multiple entries. Any attempt to submit more than one entry by any entrant will result in those entries being voided and disqualification from the Sweepstakes.

- 6. PRIZE: The Sponsors will award Five (5) Grand Prizes consisting of:
 - \$100 Redner's Markets Gift Cards. No Expiration Date. The Approximate Retail Value ("ARV") is \$100.00 USD.

All prizes are non-refundable and cannot be exchanged for cash. A prize winner cannot assign or transfer his or her prize to another person. Total ARV of all prizes is \$500.00 USD.

- 7. **ODDS:** The odds of winning a Sweepstakes Prize depend on the number of eligible entries received.

The decisions of the Sponsors will be final and binding and cannot be appealed. Prize winner will be notified by email and/or phone shortly after the drawing. On or about April 16, 2022, the Sponsors will randomly draw the winner. The Prize winners will be notified on or about April 16, 2022. The winner must meet all eligibility requirements.
